To review the existing Cooperation Agreements that exist with the various local municipalities and the subsequent Payment in Lieu of Taxes, (PILOT), and to enter into negotiations with same, to establish a communication link with local units of government to better utilize diminishing resources and to discuss the continuation of PILOT payments. To purchase reference materials and manuals, etc., computer equipment to aid in the streamlining, record keeping in the maintenance department. To educate, inform, and train all existing staff and the PHA Board Commissioners to PHAS and SEMAP regulations. To formulate a list of work items that is clearly prioritized, documented with defined nd well thought out objectives. To formulate a 501C.3, non-profit status, to potentially assign cash assets to disburse assets appropriately and to ensure growth in both size and scope.

The Plan has been formulated with the involvement of the residents, staff, as well as the community at large. The Plan and subsequent submittals may be modified to reflect changing conditions encountered. The purpose of the Plan is to provide a framework for local accountability and an easily identifiable source by which public housing residents, participants in the tenant-based assistance program, and other members of the public may locate basic PHA policies, rules and requirements concerning the operations, programs, and services. According to HUD both the Annual Plan and the 5 Year Plan creates the opportunity for strategic planning and citizen participation to take place in a comprehensive context; it allows local governments, opportunity organizations, and citizens, to address the larger picture in which these programs operate, offering the Iron County Housing Commission a better chance to shape the various programs into effective coordinated strategies. - E. Develop linkages between the housing and service sectors to provide greater housing opportunities for households special needs, and;
- F. Establish a suitable living environment and expand economic opportunities for low and moderate income through economic and infrastructure development.

- A. Housing Needs of Families on the Public Housing and Section 8 Tenant- Based Assistance Waiting Lists Currently the Iron County Housing Commission has a rather lengthy waiting list. In the twenty one (21) years that I have been the Executive Director I have never experienced the waiting list to be this extensive. Currently, all units in public housing and all Section 8 Housing Choice Vouchers are leased. For this Fiscal Year, 100% occupancy and leasu up rates have been observed for this PHA.

#### **B.** Strategy for Addressing Needs

Provide a brief description of the PHA's strategy for addressing the housing needs of families on the PHA's public housing and Section 8 waiting lists **IN THE UPCOMING YEAR**, and the Agency's reasons for choosing this strategy.

As previously stated never in the history of the Iron County Housing Commission has the waiting list been this extensive. This PHA has almost doubled the size of its Section 8 Housing Choice Voucher Program over since the enactment of QHWRA. We have attempted to secure additional Vouchers in FY 2004, but have been advised that no money is currently available. With such an extensive waiting list and limited resources available this PHA shall continue to provide housing assistance to all eligible families within these constraints. It must be pointed out that initially the Iron County Housing Commission totaled 104 unit of public housing. At present the Iron County Housing Commission has grown to 324 units of either public housing, Section 8 Housing Choice Vouchers, and the January 1, 2004, incorporation of the Woodridge Apartments, this agency has demonstrated over the course of time that it is willing to expad in size and scope. Additionally, this PHA has successfully completed its Family Self-Sufficiency Program, (FSS), with ten (10) participants on the Section 8 program achieving homeownership.



### A. PHA Progress in Meeting the Mission and Goals Described in the 5-Year Plan

The Iron County Housing Commission has successfully closed out its FSS program during this period. All required ten (10) families have secured homeownership and/or self-sufficiency. Over \$26,000.00 in FSS escrow was paid out far ahead of the HUD established deadline for closure. Additionally, the Iron County Housing Commission during this time frame has assumed the management and maintenance responsibilities of the Woodridge Apartment complex, as administered by the USDA, Rural Development. This allows more leverging of financial resources. We have maintanined high performance status concerning PHAS-public housing and SEMAP-Section 8 Housing Choice Voucher program. We have a far greater income mix of residents than we did prior to FY 2000. However, pitfalls remain. We shall face these challenges of the future as demonstrated in the past.
