We feel that we have made progress in our mission of providing drug-free housing as we have evicted four families who were found to have drugs in their units or on the property. Our drug dog contract is highly effective in keeping out drug abusers. We are doing a better job of re-leasing after units are vacated. We are annually surveying residents for satisfaction and soliciting suggestions for improving customer satisfaction. We have incorporated several suggestions from residents into our Capital Fund Budgets and our Tenant Services area of our PHA budget. We have included several new landlords in our Section 8 program, and are constantly telling others about the advantages of participating in our program.
