Executive Summary:

The Housing Authority of Trempealeau County has prepared this Agency Plan in compliance with Section 511 of the Quality Housing and Work Responsibility Act of 1998 and the ensuing HUD requirements.

We have adopted the following mission statement to guide the activities of the Housing Authority of Trempealeau County.

The mission of the Housing Authority of Trempealeau County to serve the citizens we serve by providing affordable housing opportunities in a decent, safe, environment, without discrimination, as they strive to achieve self-sufficiency and improve the quality of their lives, through participation in our public housing and housing choice voucher programs. This mission shall be accomplished by a fiscally creative organization committed to excellence in public service.

We have detailed our goals and objectives for the next five years in our Agency Plan. Our Annual Plan is based on the premise that if we accomplish our goals and objectives we will be working towards the achievement of our mission.

The plans, statements, budget summary, policies, etc. set forth in the Annual Plan all lead towards the accomplishment of our goals and objectives. Taken as a whole, they outline a comprehensive approach towards our goals and objectives and are consistent with the Consolidated Plan.

1. <u>Statement of Housing Needs</u> [24 CFR Part 903.12 (b), 903.7(a)]

According to the 2000 Census there are 11,482 housing units in Trempealeau County, of which 10,747 were occupied housing units, leaving 735 vacant units. The 735 vacant units included 222 units that were seasonal or recreational units.

There are 2,788 rental units in Trempealeau County. Of these units 688 are low income government subsidized units, or 24.68% of the total. These 688 units are broken down in 434 units for the elderly, 215 units for families, and 39 units for handicapped and disabled. The estimated poverty rate in Trempealeau County for 2002 is 8.3%. The rental vacancy rate is 6.4%, with the home owner vacancy rate at 1.4%. The vacancy rate of the low

income government housing in Trempealeau County is currently 14% per Rural Development.

The major vacancies appear to be in mixed housing serving both the elderly and families. It also appears that the worst vacancies are in low income tax credit projects.

Trempealeau County's Public Housing is located in four rural towns of Trempealeau County with 24 units of elderly in Arcadia, and 16 units of elderly in Galesville.

Twenty family units of Public Housing are located in Whitehall, Galesville, Blair and Arcadia. Historically the vacancy rate for the family units is low. Over the past years vacancy rate for the family units is low. Over the past years, vacancy problems were located at the Arcadia Elderly, with full occupancy at Galesville.

Over the past year however, this has changed with increasing vacancies in Galesville and full occupancy in Arcadia.

All of Trempealeau County's Elderly Housing was constructed in the late 1970's and early 1980's. Many of the original occupants are now moving to other housing choices such as nursing homes and assisted living units. These choices were not available (in the 1970's and 1980's market) in the same number as in today's market. Other government programs such as COP (Community Options Program) in-home health care, visiting nurses, meals on wheels, and the transportation programs allow seniors to stay in their homes longer.

The current vacancy rates in both elderly and family housing lead me to believe that Trempealeau County <u>does not</u> need additional low income housing units in the foreseeable future.

Trempealeau County also has 222 units of the Section 8 Housing Choice Vouchers. This tenant-based program has been very popular.

The waiting list for this program has never been closed. However, severe budget problems with the Section 8 Program may result in the Housing Authority being unable to assist all applicants for the Section 8 Program in a timely manner, and the average length of time the applicants are on the waiting list is lengthening. 




