9:10 A.M. – Meeting called to order

Ms. Anderson distributed copies of the changes to the Section Administrative Plan passed by the Affordable Housing Advisory Committee (AHAC). Also presented were the new "Local Preferences" and the plans for opening the waiting list.

There was a discussion about the changes in the Section 8 Administrative Plan, Local Preferences and opening the waiting list:

1. Working Families and the inclusion of Elderly and Disabled Families.

The discussion focused on how long the waiting list had been closed and that the last families to be admitted had been waiting for almost 4 years. Working families are now a priority since there is little affordable housing in Citrus County and this will give these families the opportunity to get assistance while they are trying to better themselves. It was stated that the Elderly and Displaced families always are in need of assistance because of low income.

2. Families displaced due to Domestic Violence.

The discussion focused on what kind of verification was needed to qualify for this preference.

It was emphasized that the waiting list is going to be opened but no firm date has been set. Ms. Farrar questioned what process had to take place before opening the waiting list. Ms. Anderson explained that the changes had to be approved by the Board of County Commissioners and before that can happen, the Administrative Plan and Application must be revised.

Ms. Anderson also explained that because the funds received from HUD for the HCVP are now budget based and not on how many vouchers are issued, the housing agency must be careful as to how many vouchers are issued. It was explained that the HA cannot issue more than 101 vouchers, but because of the budget, only 98 vouchers are currently issued and that an additional 2 may be issued.

There was discussion about how the rents have gone up considerably during the past year and how the Section 8 clients are having a difficult time finding reasonable rentals. These are the same problems that have been facing the HCVP participants for a couple of years. Ms. Farrar and Ms. Warino both expressed interest in the First Time Home Buyer's Program offered by Citrus County Housing. There was a lengthy discussion about the price of land, building a new home and prices of existing homes.

The meeting was adjourned at 10:00 a.m.
