

The Board and Staff of the Housing Authority have made progress in meeting the goals for the agency. We have reduced vacancy and turn around time over the five years. We have established internal monitoring and reporting for documentation and certification of the MASS submission and our Capital Fund program is on schedule. The Authority is financially stable and has been a high performer under PHAS for the past five years. There have been no findings on our annual IPA Financial Audits. We have worked with the community and local police to reduce crime and improve the safety of our neighborhoods and have established an active Community Watch Program. We believe we have made progress in improving the quality and appearance of our public housing stock.
