The Housing Authority of the City of McAlester (MHA) has a board of commissioners at the top of its hierarchy. This Board of Commissioners is appointed by the McAlester City Council and has a resident member. The day to day operations of the MHA are ran by the Executive Director, who is directly accountable to the Board of Commissioners. Under the Executive Director are 5 operations of management that are accountable to the Executive Director all having relatively equal level of hierarchy.

The first management operation is the Public Housing Rentals Manager. This person is responsible for leasing units to tenants and managing tenants. There is also a Case Intake Worker that processes applications and is accountable to the Rentals Manager and Executive Director.

The McAlester Housing Authority received a few comments from residents after viewing the PHA Plan. One elderly/disabled person asked if call for aid switches could be placed in units because she was afraid of falling and getting hurt and she did not have a phone. The same resident also suggested putting windows in the bedrooms in the MHA 0 bedroom units. (Triplex 0 bedroom units do not have any windows in the bedroom.) Another resident questioned why project 62-001 received air conditioning last even though it was the oldest project. A couple residents commented that the Handicapped accessible signs in their projects were non readable and faded, that other people were parking in the handicapped spots. One of those tenants also stated that the mailboxes in her project were not handicapped accessible, that the MHA may want to check the mailboxes. She also said the Handicapped parking in her project did not have a sign and that the parking in her area was a nightmare all around. Another tenant asked that the parking lots have lines painted separating the parking spaces. One elderly person mentioned that it would be nice to have the street gutters cleaned in her area. Another tenant thought it would be good for there to be a program to help elderly and disabled with their mowing. Another tenant commented that the new mailboxes that the Post Office installed were not waterproof, that her mail got wet.

The McAlester Housing Authority added another line item on the 2006 CFP for Handicapped Accessibility Improvements to address the need for new HC signs and painted parking spaces. In addition the MHA will be looking at the area with the mailboxes that are not handicapped and consider making accessibility improvements at that location.

The McAlester Housing Authority is required to consider all comments. In the following paragraphs, the MHA will address each comment explaining if it is

something the MHA might consider for the future or something that will not be considered for whatever reason.

The first comment was about the call for aide buttons. The MHA has been eliminating these switches over the past few years as the break down as we cannot get parts for the existing switches. In addition numerous complaints on the existing switches deters the MHA from installing new switches. The cords on the switches must hang all the way to the floor or it is a health and safety violation. Many tenants tie these cords up causing a REAC deficiency. In addition, pets like to play with the cords and cause the alarms to sound when no one is home. For these reasons, call for aide switches will probably not be included in any future plans. This same tenant commented on wanting a window in her windowless bedroom. This is a very good comment and the MHA agrees the bedroom does need a window. However, the expense of cutting a 2 foot hole through a brick wall is a deterrent to this idea. Possible tube/skylight lighting might be an easier solution that can be considered in the future.

Project 62-001 did not get air conditioning first because the MHA felt it was needed in the elderly/disabled project first due to the heat causing health problems for the elderly. There was no reason why the other projects were chosen in the order they were after that. Although Project 62 001 is the oldest project, none of the projects had Air conditioning and therefore this was a new item and not a replacement of an old item that had worn out which would have caused the oldest project to get the Air conditioning soonest.

As for the handicapped accessibility signs and parking that was brought up; the MHA agrees that these are problems that need to be addressed and has put a line item in the 2006 CFP to address some of the accessibility concerns.

A tenant spoke about marking the parking lines between cars in the parking lots. This is a good idea and may be considered when the MHA addresses the accessibility problems, as the lines for the Handicapped accessibility will need to be marked.

The parking lot on Rock Street is a nightmare. We have some money budgeted in the 5 year plan to address some parking issues so we hope that will be addressed in the next few years.

As far as cleaning the streets. We have in the past gotten trustees to clean some areas and do have community service people cleaning up, but the MHA doesn't know how safe it would be to have these volunteers walking and sweeping street. The city of McAlester is responsible for cleaning the streets and does have a street sweeper, but with their budget constraints, it does not come by very often. The MHA may have the trustees do some cleaning but don't guarantee the streets will be cleaned.

A mowing program for the elderly/disabled is a good idea but the MHA will probably not implement it. The MHA currently mows some yards due to the close

proximity of the yards and the fact they are duplexes and triplexes. In addition, singling out elderly/disabled for these services may cause a backlash of other tenants claiming they need the same service for various reasons. This project would be extremely costly and a political nightmare.

As for the new mailboxes not being waterproof, the MHA did not install or request those boxes. The MHA will contact the Post Office and see if there is anything that can be done to rectify this situation.

5 Year Plan Mission and Goals Progress Report

The following is a progress report for the goals and objectives listed in the 5 Year Agency Plan. We are meeting some of the goals set, but there are some that we still need to work on.

The vacancy rate is currently 5%, a lower than our original vacancy rate. We do not have a current PHAS score due to REAC not completing the Physical Inspections as of yet. We have received our 2005 SEMAP score, which was 100. If you will look at the Resident Survey tables below, you will notice that some of our scores have increased while.

We are currently modernizing our public housing units. Central Air is being installed in all the MHA units. We are still providing security to residents.

Our projects are exempt from the Deconcentration Requirements because they are below 30% of the Area Median Income. But, our Deconcentration Analysis did show a need for action therefore we did implement a Deconcentration Policy in our Admissions and Occupancy Policy to address this need for action. We have three projects outside the acceptable range of incomes determined by our Deconcentration Analysis. Since our average income is less than 30% of the MFI for our area, our units are exempt from HUDs Deconcentration Requirements.

We originally had 109 families with wage income with a goal of 115. We currently have 109 families with wage income. Not better, but not worse. We are still providing referral services to elderly persons, people with disabilities, and all other residents.

The McAlester Housing Authority assures access to assisted housing regardless of race, color religion, national origin, sex, familial status, and disability. We have made minor changes to units to assist persons with disabilities. In the past, we have conducted outreach activities by sending a notice to businesses and agencies within the community explaining the Public Housing Program in English and in Spanish.

We feel that we have achieved most of the goals set with the 5 Year Plan. We have some goals/objectives that need work and we will make an effort to correct those deficiencies.

Attachment C

Resident Membership of the PHA Governing Board

The McAlester Housing Authority (MHA) Board of Commissioners (BOC) does have a resident member of the board. Members of the MHA BOC are appointed by the City of McAlester Board of Commissioners. The term for board members is 4 years.

The resident board member is Betty Pickle. She was originally appointed on June 26, 2001 and her term expired on July 26, 2005 but was reinstated to a term that will end July 21, 2008.

Attachment D

Pet Policy

The McAlester Housing Authority (MHA) had adopted a pet policy with the submission of the 2001 Annual Plan.

The MHA allows pets in public housing developments. Residents must get prior written approval before getting the pet. We have a pet ownership form that must be filled out before requests will be approved. The form has basic information provided by the vet so as to ensure the pet has had proper inoculations.

Each household is only be allowed one pet. Any pet deemed to be potentially harmful to the health or safety of other, including attack or fight trained dogs, are not allowed. No animal may exceed 20 pounds in weight.

Residents are required to pay for any damages caused by the pet. Any pet related pest infestation will be the financial responsibility of the pet owner.

If the pet becomes a nuisance or threat to health or safety, the pet will have to be removed or the owner will face eviction. Visiting pets not registered will be allowed to stay for two weeks.

Pets may not be unattended in a dwelling unit for over 10 hours. Pets cannot be kept, bred or used for any commercial purpose. Cat owners shall dispose of litter box waste in an appropriate manner. Owners must restrain/confine pets at times when agents of the Housing Authority must enter the unit.

The MHA's Grievance procedures shall be applicable to all individual grievances or disputes arising out of violations or alleged violations of this policy.

Attachment F

**Deconcentration Analysis
February 2006**

The Public Housing Reform Act requires the McAlester Housing Authority to conduct a Deconcentration Analysis of its Public Housing developments each year. This analysis must be reported in the PHA Annual Plan and the Admissions and Continued Occupancy Policy with an explanation of any discrepancies in the analysis. The McAlester Housing Authority must also adopt Deconcentration Policies in its Admissions and Continued Occupancy Policy to rectify these discrepancies.

To be considered in compliance with Deconcentration regulations, the average income of each individual development must be similar to the average income of the entire PHA. Housing Authorities may substitute the medium income for the average income with a justification of the substitution. Also, Housing Authorities may use a bedroom adjustment to figure the average/medium incomes. To be in compliance, the average/medium income of the individual development must be within 15% of the average/medium income of the entire development.

In February of 2006, the McAlester Housing Authority conducted its Deconcentration Analysis. The results are as follows.

As you can see, the MHA does have a problem with some projects not being in compliance using the average income limit with and without the bedroom adjustment. When the bedroom adjustment is applied, two projects are outside the income guidelines. The MHA will be applying our Deconcentration Policies to its Projects to bring the incomes within limits.

The MHA Deconcentration Policy contains incentives the MHA can offer applicants to increase appeal in targeted developments. These incentives include, but are not limited to:

1. Allow families to skip ahead on the waiting list if their income is such that it helps deconcentrate income levels of the McAlester Housing Authority projects.
2. Offer of a bigger unit so as to increase the appeal of the targeted development.
3. First month rent remainder waived if applicant is willing to move into targeted development.

Project 62-004 only has three units in it and it is very hard to deconcentrate a project with this few units, as the turnaround is very low.

Project 62-005 is higher income than the other projects but it is only marginally over the income guide. The MHA suspects that this may be due to larger families and thus larger family incomes as this project has several 4 and 5 bedroom units where other projects may not have these large of units. Also, this project is scattered with single family units instead of duplexes and triplexes like other projects. People with higher incomes are able to wait for the scattered units to become available while people with lower income may have to take the higher turnover projects.

According to HUD, no development whose income is below 30% MFI can be considered above the Average Income of the Development. All of MHA's developments are below the 30% thresh hold and therefore are exempt and not subject to Deconcentration guidelines. The MFI of Pittsburg County for 2006 is \$42,000 which 30% would be \$12,000.

In conclusion, the Deconcentration Analysis did show a discrepancy in incomes among the projects owned by the MHA when using the average income. Even though the MHA developments are exempt, we will be using deconcentration policies to equalize development incomes.

Voluntary Conversion Statement

The McAlester Housing Authority has 4 developments that are eligible for voluntary conversion of Public Housing units to Section 8 Vouchers. They are:

62-003 is an elderly/disabled project

At this time the McAlester Housing Authority has looked at the feasibility of converting these units to Section 8 Vouchers and determined that it would not be beneficial at this time. The conversion would not help the vacancy rate at any of the projects and would not financially benefit any Section 8 participants to the extent Public Housing can benefit them. Additionally, the additional workload associated with converting the units would adversely affect the operations of the McAlester Housing Authority.
