**PHA Certifications of Compliance with the PHA Plans and Related Regulations:
Board Resolution to Accompany the *Streamlined Annual PHA Plan***

Acting on behalf of the Board of Commissioners of the Public Housing Agency (PHA) listed below, as its Chairman or other authorized PHA official if there is no Board of Commissioners, I approve the submission of the streamlined Annual PHA Plan for PHA fiscal year beginning 07/01/2007, hereinafter referred to as the Streamlined Annual Plan, of which this document is a part and make the following certifications, agreements with, and assurances to the Department of Housing and Urban Development (HUD) in connection with the submission of the Streamlined Plan and implementation thereof:

1. The streamlined Annual Plan is consistent with the applicable comprehensive housing affordability strategy (or any streamlined Plan incorporating such strategy) for the jurisdiction in which the PHA is located.
2. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, and provided this Board or Boards an opportunity to review and comment on any program and policy changes since submission of the last Annual Plan.
3. The PHA made the proposed streamlined Annual Plan, including policy and program revisions since submission of the last Annual Plan, and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the streamlined Plan and invited public comment.
4. The PHA will carry out the streamlined Annual Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
5. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.
6. For streamlined Annual Plans that include a policy or change in policy for site-based waiting lists:
The PHA regularly submits required data to HUD's MTCS in an accurate, complete and timely manner (as specified in PIH Notice 99-2);
 - The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
 - Adoption of site-based waiting list would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
 - The PHA shall take reasonable measures to assure that such waiting list is consistent with affirmatively furthering fair housing;
 - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR part 903.7(b)(2).
7. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
8. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
9. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
10. The PHA has submitted with the streamlined Plan a certification with regard to a drug-free workplace required by 24 CFR Part 24, Subpart F.
11. The PHA has submitted with the streamlined Plan a certification with regard to compliance with restrictions on lobbying required by 24 CFR Part 87, together with disclosure forms if required by this Part, and with restrictions on payments to influence Federal Transactions, in accordance with the Byrd Amendment and implementing regulations at 49 CFR Part 24.
12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.
13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
14. The PHA will provide HUD or the responsible entity any documentation that the Department needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.

17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act and 24 CFR Part 35.
18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments) and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments.).
19. The PHA will undertake only activities and programs covered by the streamlined Annual Plan in a manner consistent with its streamlined Annual Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its streamlined Plan.
20. All certifications and attachments (if any) to the streamlined Plan have been and will continue to be available at all times and all locations that the PHA streamlined Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the streamlined Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its streamlined Annual Plan and will continue to be made available at least at the primary business office of the PHA.

Progress Report for FY 2005
First year of 2005 - 2009 Five-year Plan

Goal: Expand the supply of assisted housing.

Objective: Apply for additional rental vouchers.

Accomplishment: Santa Ana Housing Authority (SAHA) applied for additional vouchers from the U. S. Department of Housing and Urban Development (HUD) each time they were made available. The number of vouchers administered by SAHA has risen from 1,900 to 2,558 since the year 2000.

Objective: Leverage private or other public funds to create additional housing opportunities.

Accomplishment: The Housing Authority did not construct any new units during the year.

Goal: Improve the quality of assisted housing.

Objective: Improve voucher management.

Accomplishment: SAHA has maintained its status as a “high performing” housing authority, hitting its target of 96% for the past year.

Objective: Increase customer satisfaction.

Accomplishment: Those attending the December 10, 2005 Tenant Advisory Meeting reported overall satisfaction with customer service.

Objective: Concentrate on efforts to improve specific management functions.

Accomplishment: Implementation of computerized, hand-held data recording equipment to increase standardization of HQS inspections began in 2005.

Accomplishment: Implemented automated rent reasonableness program.

Goal: Increase assisted housing choices.

Objective: Provide voucher mobility counseling.

Accomplishment: SAHA provided mobility counseling to 100% of tenants.

Goal: Improve community quality of life and economic vitality.

Objective: Undertake affirmative measures to ensure accessible housing to persons with all varieties of disabilities regardless of unit size required.

Accomplishment: As stated in SAHA's Administrative Plan, exceptions are made as reasonable accommodations to persons with disabilities, including higher payment standards for modified units and voucher extensions to find new units.

**Tenant Advisory Meeting
December 9, 2006**

This meeting was attended by 79 participants, the majority of whom spoke either Spanish or Vietnamese as their primary language. The Santa Ana Housing Authority's bilingual staff members were able to facilitate a free exchange of ideas, including feedback on customer service. Possible changes to the program under the flexible voucher proposal were presented, including time limits on assistance and the effects of different approaches to subsidy, such as flat rents and tiered rents. Comments received are summarized below.

What do you enjoy about where you live?

- Close to friends and family
- Clean and in good repair
- Quiet and safe
- Near schools, bus stops, and shopping centers
- Friendly and responsive management

What do you **not** enjoy about your neighborhood?

- Not enough / improperly enforced visitor parking
- Too close to railroad tracks
- Not enough dumpsters at complex
- Annual rent increases from owner
- Vandalism/graffiti
- Difficult to communicate with management/owner
- Not enough tenant parking
- Other units in complex are overcrowded
- Owner enters unit without permission

If you could change one thing in your neighborhood, what would it be?

- Need traffic light on First between Harbor and Newhope
- Additional security in complex
- More open space / parks / play areas
- More parking / underground parking

What do you think the Santa Ana Housing Authority does well?

- Service at reception is excellent
- Calls responded to quickly
- Case workers are responsive to tenant concerns
- Communication between tenant and case worker is good

What service areas by the Santa Ana Housing Authority could be improved?

- Seniors need to move off waiting list more quickly
- Tenants would like more advance notice of annual re-examination appointments
- Tenants would like more advice and counseling at annual appointments\
- More information on FSS program
- More information on neighborhood council meetings
- If able-bodied, tenants should be required to work/earn income

What Santa Ana Housing Authority policy changes in the past year have affected you?

- Increased mobility within Orange County was positive

For how long do you see yourself requiring rental assistance?

- Five years (FSS participant)
- For elderly or disabled, forever
- Five years (working family)
- Five to ten years

A possible change is time limits. What would you do if your assistance stopped in 5 years?

- Move in with others, share housing
- Become homeless
- Get additional jobs for increased income
- Don't know; desperation

A possible change is flat rents (e.g. \$500 for 1 bedroom, \$750 for 2 bedroom).

What impact would that have on your family?

- Concern whether it would accommodate rent increases
- The ability to keep all of wage increases is attractive

Would you prefer the current program with time limits, or the flat rent program with time limits?

- Flat rents with time limits would create incentive for upward mobility and education
- 70% of Vietnamese language group preferred no time limits
- 60% of Spanish language group did not want flat rents
