LHA currently is working with 4 FSS participants that are about to graduate FSS and are interested in pursuing Homeownership.

Establishing a minimum homeowner downpayment requirement of at least 3 percent of purchase price and requiring that at least 1 percent of the purchase price come from the

Longview has administered a successful First Time Home Buyers Down Payment/Closing Cost Assistance grant program for a number of years. PHA will seek to work actively with HUD Fort Worth in order to implement program during 07-08.
