Deconcentration Policy

It is Housing Authority of the County Jersey's policy to provide for deconcentration of poverty and encourage income mixing of lower and higher incomes in our family developments, which include but not limited to Jersey Acres/Homes IL074-001, Jersey Villa IL074-004, and Windy Hills Apts. IL074-005. We will accomplish this in a uniform and non-discriminating manner.

Prior to the beginning of each fiscal year, the Housing Authority of the County of Jersey will analyze the income levels of families residing in each of our developments using the method found in 24 CFR Part 903.

If the Housing Authority of the County of Jersey's family developments average income is to fall lower or higher than 85% - 115% of the PHA-wide average income, the Housing Authority will implement a deconcentration incentive to encourage families with income above or below the established income range to accept units in the developments that are lower or higher than 85% - 115% of the PHA-wide average income.

The Housing Authority of the County of Jersey has installed carbon monoxide detectors in all of the public housing units that use combustible gas.

The Housing Authority of the County of Jersey has required all Section 8 Voucher landlords to install carbon monoxide detectors in all units that use combustible gas that are subsidized through the Section 8 Voucher Program. The unit will not pass HQS inspection without a working carbon monoxide detector.

Violence Against Women Act Resolution 1-2007

The Housing Authority of the County of Jersey has adopted the Violence Against Women Act whereas the Housing Authority of the County of Jersey will protect certain victims of criminal domestic violence, dating violence, sexual assault, or stalking as well as members of the victim's immediate families, from losing their HUD assisted housing as a consequence of the abuse of which they are the victim. The victim of abuse must certify that the alleged incidents of abuse are bona fide. The Housing Authority will only accept statements from law enforcement agency.
