The supply of units appears to be adequate but not affordable. Because of the lack of affordable rental housing in our area, assisted housing continues to be necessary and desired by those living in our authority district and those on our waiting lists.</p>

An orientation is held at the onset of residency with the tenant. Brochure packets with many sources of information are given to all new landlords and tenants. Residents are assisted by staff to obtain appropriate housing and the inspector monitors the residence annually and quality control inspections are completed as required on selected properties.</p>

Provide a brief statement of the PHA’s progress in meeting the mission and goals described in the 5-Year Plan.</p> <p>We work closely with other area organizations to promote self-sufficiency and to provide decent, safe, and affordable housing to low income for the elderly and disabled persons for the community of Posey County. We provide a living environment free of discrimination and housing that is suitable for all individuals eligible by following our Public Housing Policies. Our SEMAP score for the last three years has ranged from 96%-100%. This has been accomplished through diligent enforcement of case monitoring and supervisor review of charts.</p> <p>(b) Significant Amendment and Substantial Deviation/Modification. Provide the PHA’s definition of “significant amendment” and “substantial deviation/modification”</p> <p>Funds from one year’s plan may be utilized to accomplish any work items scheduled during the five-year plan and shall not be considered a substantial deviation.
