Maintain low vacancy rate by advertising availability of homes to lease and constant maintenance of a waiting list of eligible applicants. The Housing Authority of the City of Iola promptly contacts the next eligible family on the waiting list of an available home. We maintain an open waiting list for all size homes and diligently advertise throughout the area when it appears the list may not fill future vacancies. We have increased our occupancy percentage over the past five years from 95% to 97%. 2. Improve the quality of assisted housing. We shall endeavor to continue to maintain the high quality maintenance our residents have come to expect. We are pleased that we have consistently rated above average in our PHAS Physical Assessment System Scores. Our continued practice of long term planning for unit modernization, replacement of equipment, prompt repair of damage and scheduled preventative maintenance will serve to provide our residents with homes in which they may be proud to live. We work to maintain our current high performer status. 3. Provide an improved living environment and community quality The Housing Authority of the City of Iola maintains a good working relationship with the city police department. This cooperation has served both agencies as we communicate possible problems which allow the police to monitor closely and often serves to deter criminal activity. Our residents are encouraged to notify this office of any complaints or disturbance so we may intervene before minor situations evolve into more major events. We completed our goal to implement a new key/lock system throughout the project so keys are made only through this office and may not be copied by any local locksmith or store. This, along with the steel entry jambs and doors has proved to be a huge improvement in the sense of security our residents have. 4. Promote self-sufficiency and economic vitality The Housing Authority of the City of Iola strives to provide information of job availability and to cooperate with community service groups such as Social and Rehabilitation Service (SRS), Job Training programs, The Farm, SafeBase school programs and other self-sufficiency groups. We have an agreement with the Allen County College to provide GED classes and testing free to any of our residents. We continue, as in past years, to provide a meeting place for those members of Resource Center for Independent Living, Southeast Kansas Mental Health groups and classes, and the family preservation or training classes sponsored by SRS. 5. Equal Housing Opportunity The Housing Authority of the City of Iola is sensitive to the accessibility needs of our residents and takes such into account during our various modernization projects. We shall continue to undertake affirmative measures to ensure housing for all indiscriminately.

It was recommended that a drain be installed around the home to remove any water pressure perhaps from an underground spring that may be causing the bulging. Recommendations were that it may take a year or so to really determine whether the drain is the solution. It appears to have improved somewhat, however we are still unsure if the improvement will hold or whether we will need to apply for demolition of this duplex and request to build on a more solid site. Only one side of the duplex appears to be affected at this time. A decision will be made within these next five years.</p>

The flood of 2007 demolished many of the smaller rental homes on the south side of the city. The area is now designated as a flood plain and future building is not allowed, therefore many families were forced into public housing or to move elsewhere. Although a new housing development for "low-moderate income" families and another for elderly families is being built through grants obtained by the city of Iola and developers, the monthly cost of renting these homes is still far out of reach of the population we serve. The flexible rents of public housing allows the tenant assurance that an affordable, well maintained home with adequate utilities is available to them when times are rough.</p>

We have established preferences to our waiting list to help ensure housing for those eligible families most in need and work closely with other service organizations to keep them aware of housing opportunities for those they serve.</p>




