Affordability and Supply

Auburn Housing in order to avoid reducing the number of vouchers has maintained our payment standards for our Section 8 program at below 100%. This reduction in subsidy has increased the housing burden for our affected tenants. Rents in the area for “good” units continue to out-pace HUD’s published FMRs.

Size and Location of Units

Auburn Housing has 177 Public Housing and 590 Housing Choice Vouchers. The vouchers gives families a choice of town/country living in a jurisdiction that covers 5 towns and two counties beyond Auburn itself. In most cases, families and individuals are able to locate units. However, affordability is affecting the availability due to our lower payment standards.

13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
18. 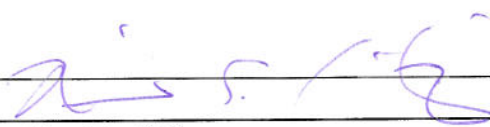
