The identification of housing needs must address issues of affordability, supply, quality, accessibility, size of units, and location.</p> <p>*Based on our plan jurisdiction and HUD's goals we know we are in need of affordable housing. For the past five (5) years we have requested funds at budget time from the Meeker County Board of commissioners (appointing body), for a supplemental voucher program whereby we could provide local vouchers for up to ten (10) families. The components of the supplemental program have been proposed to be the same as those currently in place with the section 8 voucher program. We have requested roughly \$36,000/annually (\$250 HAP \$40 Admin - \$300 units x 10 units x 12month). Through this effort, we could continue to support low-income residents and increase affordability within the county where our current HAP does not cover our baseline units. This has unfortunately been denied.</p> <p>*we have been in the process for the last six (6) months of updating our housing list to more closely resemble HUD's Section 8 Request for tenancy Approval form. This will make it easier to identify affordable housing units a "quick calc" can be done to assist clients faster when making housing selections.</p> <p>*Nearly 100% of households are classified as 1=white 2=not Hispanic or Latino</p> <p>* Public housing clients are at income levels classified as Extremely Low-All (60%), Very Low -All (24%), Low-All (12%), and Other-All (4%). Forty percent have been assisted for more than 5 years. Twenty four (24%) have been served for a year. Thirty-six percent (36%) have been assisted 2-4 years.</p> <p>*Section 8 client income levels are extremely Low-All (71%), Very Low-All (21%), and Low All (7%). Forty-eight percent (48%) of section 8 clients have been on the program 2-4 years.</p> <p>*Based on inquiries, there seems to be a need for affordable three bedroom units. Also, SRO units. In addition, inquiries are often made by landlords who wish to make repairs. The PHA has assisted where possible in providing grant and/or funding resource ideas.</p> <p>*Our jurisdiction is Meeker County. The county seat is the city of Litchfield. Litchfield provides housing for seventy-seven percent (77%) of section 8 clients. There is a great need for affordable housing units in smaller communities as well. We are bordered by Wright County, Stearns County and the City of St. Cloud. HUD's FMR's are drastically lower in Meeker than our bordering areas. In fact, Eden Valley, a town in our jurisdiction is cut half between Stearns County and Meeker County. This large difference is payment standards often cause renters confusion when seeking housing options.</p> <p>* According to the consolidated plan in 2010 analysis of unmet needs, there will be 296,740 families in MN needing housing assistance. Of the 296,740 families:  30% are at 30% of median household family income, of these 44% are senior households  35% are at 30-50% of median household family income, of these 33% are senior households  18% are at 50-60% of median household family income. of these 13% are senior households  12% are at 60-80% of median household family income; of these 10% are senior households.</p> <p>Looking ahead, it is expected there would be the need for single person elderly housing to increase as the baby boomers age as noted above as SRO. Elderly persons approximately 45% of renters had some housing need and were cost burdened. Persons with disabilities- American Community Service (ACS) reports that 325,221 persons with mental disabilities &amp; 205,399 persons with mental disabilities live in Minnesota. ASC also reports that 99,000 of the Minnesota disable population had income below poverty line the past twelve months. These households most likely are rent burdened and have housing affordability issues.</p>

We are planning on opening it this year due to purging. Our public housing waiting list is always open, although we do not experience a huge turnover. Our fiscal year through 05/01/2010 turnover in Dassel. While we look for increased capacity opportunities, this can most likely only be accomplished with the cooperation of the Meeker County Board of commissioners who would govern any acquisitions we would wish to make for stabilization or increase of affordable housing.</p>

The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

Additionally, PHAs shall complete the Performance and Evaluation Report section (see footnote 2) of the *Capital Fund Program Annual Statement/Performance and Evaluation* (form HUD-50075.1), at the following times:

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

**8.2 Capital Fund Program Five-Year Action Plan**

PHAs must submit the *Capital Fund Program Five-Year Action Plan* (form HUD-50075.2) for the entire PHA portfolio for the first year of participation in the CFP and annual update thereafter to eliminate the previous year and to add a new fifth year (rolling basis) so that the form always covers the present five-year period beginning with the current year.

**8.3 Capital Fund Financing Program (CFFP).** Separate, written HUD approval is required if the PHA proposes to pledge any

portion of its CFP/RHF funds to repay debt incurred to finance capital improvements. The PHA must identify in its Annual and 5-year capital plans the amount of the annual payments required to service the debt. **9.0 Housing Needs.** Provide a statement of the housing needs of families residing in the jurisdiction served by the PHA and the means by which the PHA intends, to the maximum extent practicable, to address those needs. **(Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan).**

**9.1 Strategy for Addressing Housing Needs.** Provide a description of the PHA's strategy for addressing the housing needs of families in the jurisdiction and on the waiting list in the upcoming year. **(Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan).**

**10.0 Additional Information.** Describe the following, as well as any additional information requested by HUD:

- (a) **Progress in Meeting Mission and Goals.** PHAs must include (i) a statement of the PHAs progress in meeting the mission and goals described in the 5-Year Plan; (ii) the basic criteria the PHA will use for determining a significant amendment from its 5-year Plan; and a significant amendment or modification to its 5-Year Plan and Annual Plan. **(Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan).**
- (b) **Significant Amendment and Substantial Deviation/Modification.** PHA must provide the definition of "significant amendment" and "substantial deviation/modification". **(Note: Standard and Troubled PHAs complete annually; Small and High Performers complete only for Annual Plan submitted with the 5-Year Plan.)**

- (c) PHAs must include or reference any applicable memorandum of agreement with HUD or any plan to improve performance. **(Note: Standard and Troubled PHAs complete annually).**
