Attachment 3

Violence Against Women Act (VAWA)

The Consortium of Northwest Ohio adopted revisions to its Section 8 Housing Choice Voucher Administrative Plan to address the requirement of the Violence Against Women Act. Those revisions were adopted by of the Board of Commissioners of the Bowling Green Housing Agency, the Henry Metropolitan Housing Authority and the Williams Metropolitan Housing Authority.

The Consortium notified all current Section 8 HCV program participants through written mail of the requirements of the Violence Against Women Act. New tenants are advised of the Act when admitted to the program.

All current landlords were notified through written mail of the requirements of the Act. New landlords are advised when they are introduced to the program.

All Consortium staff were trained and training updates will be scheduled as appropriate.

The Consortium works with local social service agencies, law enforcement officials and counseling services when necessary to identify and verify victims of domestic violence, sexual assault and/or stalking. If a victim is a current participant, the Consortium follows all policies and procedures to ensure that the victim and his or her family continue to receive rental assistance and that the perpetrator is no longer present in the unit.

9.1 Strategy for Addressing Housing Needs

The Consortium of Northwest Ohio will continue to serve as many families as possible by managing the program to utilize the maximum amount of funding available. In addition, the Consortium will continue to pursue any extra vouchers or funding in an attempt to meet the needs of the very low-income families. The Consortium will also continue to participate in conjunction with other local agencies to meet local needs through other avenues when available.

9.0 Housing Needs

According to the most recent U.S. Census Bureau data, the 7 counties served by the Consortium of Northwest Ohio have the following aggregate characteristics:

- Approximately 23,070 persons (about 6.7% of the area population) are living below the federal poverty level.
- Approximately 40,492 persons (about 12.9% of the area population) are 65 years of age or older.
- Approximately 48,683 persons (about 16.8% of the area population) are classified as disabled.
- Approximately 95.3% of the area population is racially classified as White.
- Less than 1% of the area population is racially classified as Black.
- Approximately 3.9% of the area population is racially classified as other than White or Black.
- Approximately 4.5% of the area population is classified as Hispanic.

The Consortium of Northwest Ohio maintains 3 separate waiting lists; one for each PHA. The 3 waiting lists currently have a total of 287 persons seeking rental assistance. The following statistics reflect the aggregate waiting list population:

- 81.5% of the population is classified as extremely low income.
- 18.5% of the population is classified as very low income.
- 8.7% of the population is classified as elderly.
- 18.1% of the population is classified as disabled.
- 86.4% of the population is racially classified as White.
- 12.2% of the population is racially classified as Black.
- 1.4% of the population is racially classified as other than White or Black.
- 12.5% of the population is classified as Hispanic.

The Consortium of Northwest Ohio would like to be able to assist more families within its jurisdiction but is unable due to lack of sufficient funding. While there is a sufficient number of size-appropriate, rent reasonable apartments available in all areas served by the Consortium, a significant number of extremely low-income families are unable to maintain a lease.
