The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.
- 8. For PHA Plan that includes a policy for site based waiting lists:
 - The PHA regularly submits required data to HUD's 50058 PIC/IMS Module in an accurate, complete and timely manner (as specified in PIH Notice 2006-24);
 - The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
 - Adoption of site-based waiting list would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
 - The PHA shall take reasonable measures to assure that such waiting list is consistent with affirmatively furthering fair housing;
 - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR part 903.7(c)(1).
- 9. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
- 10. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
- 11. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
- 12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.

- 13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
- 14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
- 15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
- 16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
- 17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
- 18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments), 2 CFR Part 225, and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments).
- 19. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
- 20. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.
- 21. The PHA provides assurance as part of this certification that:
 - (i) The Resident Advisory Board had an opportunity to review and comment on the changes to the policies and programs before implementation by the PHA;
 - (ii) The changes were duly approved by the PHA Board of Directors (or similar governing body); and
 - (iii) The revised policies and programs are available for review and inspection, at the principal office of the PHA during normal business hours.
- 22. The PHA certifies that it is in compliance with all applicable Federal statutory and regulatory requirements.

Comment 1: How are the Family Self Sufficiency coordinator funding monies used?

Staff Response: Staff explained that the Housing Authority of the City of Napa received \$ 138,000 for 2012 under the Family Self Sufficiency program and that the monies can only be used for salary and benefits of the two FSS coordinators.

Comment 2: How many families or individuals are enrolled in the Family Self-Sufficiency program?

Staff Response: The Family Self Sufficiency program currently has 74 families/individuals enrolled. There are 81 slots available and the Housing Authority is currently enrolling new families/individuals to fill the remaining slots.

Comment 3: How is owner outreach done?

Staff Response: The Housing Authority of the City of Napa does owner outreach through presentations done at realtor and property management meetings, through question and answer sessions done at the Housing Authority office, through mailings to targeted apartment complexes and by mailings to owners and property managers.

Comment 4: Why is there a revision in regards to project based vouchers?

Staff Response: The Housing Authority of the City of Napa analysis concludes that there is a shortage of larger size units available to families and the Housing Authority should explore ways to create additional units in the voucher program for families. Project based vouchers for elderly and disabled still remain in the annual plan.

Comment 5: Can the Housing Authority provide training for RAB members and can the language in the 5 year and Annual Plan be simplified?

Staff Response: The Housing Authority can meet with the RAB and explain any parts they do not understand prior to the RAB meeting. Staff explained that form HUD-50075 cannot be altered but the Housing Authority's responses in the form can be reviewed to see if its responses can be simplified.

VAWA Attachment

This attachment responds to the requirements of the Violence Against Women and Reauthorization Act of 2005 (VAWA). This Act requires Five-Year and Annual Plans to contain information regarding the PHA's goals, objectives, policies or programs that will enable the PHA to serve the needs of child and adult victims of domestic violence, dating violence, sexual assault, or stalking.

There are number of resources in Napa County for victims of violence and sexual assault, including the following:

- <u>Sexual Assault Victims Services</u>: Provides counseling and 24-hour hotline.
- <u>Napa Emergency Women's Shelter (NEWS)</u>: Provides a safe house, counseling, and 24-hour hotline.
- <u>County of Napa Child Welfare Services</u>: Provides investigation services and 24hour hotline.

The Housing Authority has included the following provisions in its Administrative Plan to respond to the requirements of VAWA:

Notification To Participants: The HACN provides all participants with notification of their protections and rights under VAWA at the time of admission and at annual reexamination. This notice explains the protections afforded under the law, informs the participant of HACN confidentiality requirements, and provides contact information for local victim advocacy groups or service providers. The HACN also includes in all assistance termination notices a statement explaining assistance termination protection provided by VAWA.

Notification To Applicants: The HACN makes available to all applicants notification of their protections and rights under VAWA at the time they request an application for housing assistance. The notice explains the protections afforded under the law, inform each applicant of PHA confidentiality requirements, and provide contact information for local victim advocacy groups or service providers. The HACN will also include in all notices of denial a statement explaining the protection against denial provided by VAWA.

Notifications To Owners And Managers: The HACN informs property owners and managers of their screening and termination responsibilities related to VAWA. The

HACN utilizes any or all of the following means to notify owners of their VAWA responsibilities:

- 1. As appropriate in day to day interactions with owners and managers.
- 2. Inserts in HAP payments, 1099s, owner workshops, classes, orientations, and/or newsletters.
- 3. Signs in the HACN lobby and/or mass mailings which include model VAWA certification forms.
