6. **Designated Housing for Elderly and Disabled Families.** With respect to public housing projects owned, assisted, or operated by the PHA, describe any projects (or portions thereof), in the upcoming fiscal year, that the PHA has designated or will apply for designation for occupancy by elderly and disabled families. The description shall include the following information: **1)** development name and number; **2)** designation type; **3)** application status; **4)** date the designation was approved, submitted, or planned for submission, and; **5)** the number of units affected.
7. **Community Service and Self-Sufficiency.** A description of: **(1)** Any programs relating to services and amenities provided or offered to assisted families; **(2)** Any policies or programs of the PHA for the enhancement of the economic and social self-sufficiency of assisted families, including programs under Section 3 and FSS; **(3)** How the PHA will comply with the requirements of community service and treatment of income changes resulting from welfare program requirements. **(Note: applies to only public housing).**
8. **Safety and Crime Prevention.** For public housing only, describe the PHA's plan for safety and crime prevention to ensure the safety of the public housing residents. The statement must include: (i) A description of the need for measures to ensure the safety of public housing residents; (ii) A description of any crime prevention activities conducted or to be conducted by the PHA; and (iii) A description of the coordination between the PHA and the appropriate police precincts for carrying out crime prevention measures and activities.

9. **Pets.** A statement describing the PHAs policies and requirements pertaining to the ownership of pets in public housing.

Additionally, the form shall be used for the following purposes:

- (a) To submit the initial budget for a new grant or CFFP;
- (b) To report on the Performance and Evaluation Report progress on any open grants previously funded or CFFP; and
- (c) To record a budget revision on a previously approved open grant or CFFP, e.g., additions or deletions of work items, modification of budgeted amounts that have been undertaken since the submission of the last Annual Plan. The Capital Fund Program Annual Statement/Performance and Evaluation Report must be submitted annually.

Additionally, PHAs shall complete the Performance and Evaluation Report section (see footnote 2) of the *Capital Fund Program Annual Statement/Performance and Evaluation* (form HUD-50075.1), at the following times:

1. At the end of the program year; until the program is completed or all funds are expended;
2. When revisions to the Annual Statement are made, which do not require prior HUD approval, (e.g., expenditures for emergency work, revisions resulting from the PHAs application of fungibility); and
3. Upon completion or termination of the activities funded in a specific capital fund program year.

8.2 Capital Fund Program Five-Year Action Plan

PHAs must submit the *Capital Fund Program Five-Year Action Plan* (form HUD-50075.2) for the entire PHA portfolio for the first year of participation in the CFP and annual update thereafter to eliminate the previous year and to add a new fifth year (rolling basis) so that the form always covers the present five-year period beginning with the current year.

8.3 Capital Fund Financing Program (CFFP). Separate, written HUD approval is required if the PHA proposes to pledge any

portion of its CFP/RHF funds to repay debt incurred to finance capital improvements. The PHA must identify in its Annual and 5-year capital plans the amount of the annual payments required to service the debt. The PHA must also submit an annual statement detailing the use of the CFFP proceeds. See guidance on HUD's website at:

Board Resolution to Accompany the PHA 5-Year and Annual PHA Plan**

Resolution 12-14

Acting on behalf of the Board of Commissioners of the Public Housing Agency (PHA) listed below, as its Chairman or other authorized PHA official if there is no Board of Commissioners, I approve the submission of the ___ 5-Year and/or ___ X Annual PHA Plan for the PHA fiscal year beginning 2012, hereinafter referred to as "the Plan", of which this document is a part and make the following certifications and agreements with the Department of Housing and Urban Development (HUD) in connection with the submission of the Plan and implementation thereof:

1. The Plan is consistent with the applicable comprehensive housing affordability strategy (or any plan incorporating such strategy) for the jurisdiction in which the PHA is located.
2. The Plan contains a certification by the appropriate State or local officials that the Plan is consistent with the applicable Consolidated Plan, which includes a certification that requires the preparation of an Analysis of Impediments to Fair Housing Choice, for the PHA's jurisdiction and a description of the manner in which the PHA Plan is consistent with the applicable Consolidated Plan.
3. The PHA certifies that there has been no change, significant or otherwise, to the Capital Fund Program (and Capital Fund Program/Replacement Housing Factor) Annual Statement(s), since submission of its last approved Annual Plan. The Capital Fund Program Annual Statement/Annual Statement/Performance and Evaluation Report must be submitted annually even if there is no change.
4. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Board or Boards in developing the Plan, and considered the recommendations of the Board or Boards (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
6. The PHA certifies that it will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
7. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.
8. For PHA Plan that includes a policy for site based waiting lists:
 - The PHA regularly submits required data to HUD's 50058 PIC/IMS Module in an accurate, complete and timely manner (as specified in PIH Notice 2006-24);
 - The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
 - Adoption of site-based waiting list would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
 - The PHA shall take reasonable measures to assure that such waiting list is consistent with affirmatively furthering fair housing;
 - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR part 903.7(c)(1).
9. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
10. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
11. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.




Meeting began with a review of the requirement to submit an Annual Plan and the draft of the MMHA's Streamlined Annual Plan for 2012. There were no questions or comments.

Debbie Kubena-Yatsko distributed and carefully reviewed the 50075.1 and 50075.2 forms. The following discussions occurred:

- How the MMHA anticipates funds that will be received in the future. A question was asked about who decides how much each PHA will receive in funding. The process was explained starting with Congress and the U.S. Department of Housing and Urban Development.
- All in attendance were supportive of upgrades to the security system especially the addition of cameras in hallways where none exist currently. The question was asked whether cameras could be put outside in the parking lot. It was explained that staff had already look into this issue and any cameras would have to be mounted on the building and trees would block the view. The current trees help regulate the need for heat and cooling of the building. At this time, there is no crime problem therefore the cost is prohibitive. This answer was acceptable.
- All in attendance were in support of refurbishing the resident lounges. A question was asked about the possibility of new hall carpeting because the wheelchairs and scooters cause dirt and damage. It was explained that a

work order would be entered to inspect and possibly clean carpets. If the inspection should a need for new carpet it would be addressed.

- All in attendance were in support of upgrading the non-dwelling generator.
- All were in support of continuing the ongoing work of modernizing units.
- Discussion occurred regarding the upgrade to the intercom system. It was agreed the upgrade is necessary and the current system is older and beginning to show signs of problems. Much discussion occurred over whether or not the new system should allow residents to see who is ringing the buzzer from their units so that they can buzz them in. Many residents were against buzzing guests in. The pros and cons of both systems were discussed. Some residents admitted to violating current rules by letting people into the building who are not their guests and who walk around unescorted. A significant amount of meeting time was spent discussing different scenarios. It was agreed to hang new signage by the front door instructing visitors of the rules.
- All were in support of upgrades to the elevators.
- The needs for a physical assessment was discussed and residents had no questions.

Residents were given an opportunity to provide ideas for improvements. Ideas discussed were operating in nature and not capital funds so they will be addressed through work orders and routine maintenance.

There were no objections to the plan.

Violence Against Women Act Statement

The Medina Metropolitan Housing Authority (MMHA) strives to provide comprehensive, client oriented services to low-to-moderate income households in Medina County. As a result, the MMHA provides services covering situations that range from homelessness to homeownership. Some programs, while not specifically designed solely for victims of domestic violence, would provide services to victims of violence as defined in Public Law 109-162. The Housing Choice Voucher Program and North View Manor (Public Housing) have incorporated the Violence Against Women Act (VAWA) requirements into policy and procedures.

Policy

The requirements of VAWA have been incorporated in the Housing Choice Voucher Program Administrative Plan and North View Manor's Occupancy Guidelines. Submitted with this plan is the chapter of the Occupancy Policy which describes the MMHA's policy.

The Housing Choice Voucher Program initially notified landlords and clients of VAWA through a mailing. All new voucher holders are informed of VAWA at their briefing session. In addition, when a situation in which VAWA applies arises the client is reminded of their rights and provided with the certification form.

North View Manor notification occurred at a resident meeting and was followed by information in the resident newsletter. New residents are informed at move-in. Residents will be reminded of their rights when abuse situations occur.

In all situations, care will be taken to ensure that the certification requirements do not place the victim in harm's way. Forms will be available at the office and not mailed unless requested. Confidentiality will be strictly enforced.

Programs, Activities, and Objectives

In addition to following the requirements of VAWA, the MMHA provides a variety of programs, including emergency case management to those experiencing a housing crisis. Case Management includes conducting a needs assessment, referrals, and if eligible, emergency security deposit, rent and/or utility assistance. These services would be available to those experiencing a housing crisis due to domestic violence.


Staff collaborates with the Battered Women's Shelter to transition clients to and from the shelter and permanent housing. In addition, the MMHA agreed to collaborate with the BWS on a grant application they submitted and the PHA is the maintenance provider on the shelter.


