Resident Assessment and Satisfaction Survey Follow-Up Plan

Overview

The Housing Authority of the City of Lithonia received the following scores on the Resident Assessment Survey.

As a result of this survey, the Housing Authority is required to develop a Follow-Up Plan to address each section score that fell below 75%.

Communications

GOAL: To improve the quality of communication to all residents.

ACTION: Meet with the Resident Advisory Board and discuss their concerns regarding any of the sections outlined in the Survey pertaining to communication and customer service. Meet with the staff periodically to discuss the importance of communication with the residents. The Housing Authority will strive to continue to improve the quality of service we provide and address the issues brought forth by the Advisory Board. The Authority shall achieve a level of customer satisfaction that gives the Agency the highest possible score in this element of the Public Housing Assessment System. This will be an on-going process.

Safety

GOAL: To address the concern of residents pertaining to safety and security outlined in the Resident Service and Satisfaction Survey; develop programs that focus on improving security.

ACTION: The Authority will meet with the Resident Advisory Board to discuss what actions can be taken to make the developments safer for all families. The Authority will consider using Capital Funds to implement safety measures.

Neighborhood Appearance

GOAL: To improve the overall neighborhood appearance.

ACTION: The Authority shall achieve proper curb appeal for its public housing developments by improving landscaping, keeping its grass cut, making properties litter free and other actions. The Authority will also continue to use Capital Funds to modernize and renovate housing units.

Attachment E

Progress in Meeting Five-Year Plan Mission and Goals

Goal #1

The Authority has used Capital Fund monies to improve and modernize public housing units in order to compete with open market rental communities. Also, the Authority has implemented a lawn cutting and trash pick-up program to keep the outside of the units looking neat and clean.

Goal #2

The Authority is in the process of reviewing its' Preventive Maintenance procedures. During this process, the Authority will obtain information regarding the improvement in efficiency and materials. This improvement will help the Authority to improve the Physical Inspection portion of the PHAS Score.

Goal #3

The Authority received a resident satisfaction score of 94% on the Resident Assessment Survey conducted by REAC. This will be used as a baseline to measure future progress. As stated earlier, the Authority is reviewing its' Preventive Maintenance procedures. After these procedures are modified, it should help to produce even greater resident satisfaction with maintenance.

Goal #4

The Authority is in the process of identifying factors which hinder high employee morale. Once these factors are established, a plan will be developed to eliminate these factors. The Authority is also in the process of identifying organizational and staffing needs.

Attachment F

Deconcentration of Poverty and Income Mixing

After further consideration of how the deconcentration and income mixing provisions would apply to various types of public housing developments, HUD determined that certain developments should be exempt from the requirement to deconcentrate poverty because of the development's resident population, type or types of units, or number of units. Public housing developments that are exempt from application of the requirement to deconcentrate poverty and mix incomes are the following:

- Public housing developments operated by a PHA with fewer than 100 public housing units;
- Public housing developments operated by a PHA which house only elderly persons or persons with disabilities, or both;
- Public housing developments operated by a PHA that operates only one general occupancy, family public housing development;
- Public housing developments approved for demolition or for conversion to tenant-based assistance; and
- Public housing developments which include public housing units operated in accordance with a HUD-approved mixed-finance plan using HOPE VI or public housing funds awarded before the effective date of this rule, provided the PHA certifies (and includes reasons for the certification) as part of its PHA Plan (which may be accomplished either in the Annual Plan submission or as a significant amendment to its PHA Plan) that exemption from the regulation is necessary to honor an existing contractual agreement.

The Lithonia Housing Authority operates 75 public housing units and therefore, is exempt from this requirement.
